- **Homer Tree Service** sprayed the apple trees in the main island. This is the first of three treatments per season.

New Business

- Concrete repair will take place on the sidewalk to the south of the gazebo. There is a chunk of concrete missing and it is a danger to residents and guests walking in that area. Motion to approve by Irene, second by Linda.
- The board will be seeking bids for mulch in the common areas. The two areas are east side of Settlers Lane at entry to the Croft and the area to the northwest of Croft Lane where the spruce tree was removed.
